Green Energy Choice Tariff (WindChoice)

Effective Date 12-30-21

This Tariff is available to customers taking service under the Company’s standard rate schedules who wish to support the Company’s procurement of beneficial environmental attributes also known as Renewable Energy Certificates (REC’s) derived from Oklahoma-based renewable wind energy resources. Customers may purchase REC’s equivalent to a percentage of total monthly billed usage (kWh) up to 100% of their monthly load.

Net Energy Billing Option (NEBO) Rate Code 067

Effective Date 1-31-22

This tariff is available to customers taking service under their applicable standard TOD rate schedule having on-site power production facilities (limited to 300kW capacity) located on the customer’s premises and intended primarily to offset some or all of the customer’s energy usage at that location, who has signed an interconnection agreement with the company, and installed the required equipment.

Qualifying Facilities Standard Purchase Schedule (QFSPS)
Rate Code 064

Effective Date 12-30-21

This tariff is available to qualifying Small Power Producer customers taking service under the Company’s standard rate schedule having on-site power production facilities (limited to 300kW capacity) located on the customer’s premises and intended primarily to offset some or all of the customer’s energy usage at that location, who has signed an interconnection agreement with the company, and installed the required equipment.
